





The brown bars are all sources of value other than oil and gas. Yellow is oil and gas. The green bars in 2025 and 2026 show the volume of exempted residential property tax in 2025 and the preliminary estimate of residential and personal property tax exemptions for 2026. The green dashed line is the curve of the Consumer Price Index (CPI).



Residential property taxes make up more than 50% of this donut chart.

The rest includes minerals, commercial, and industrial property.

Total residential property taxes for 2025 were reduced by about \$13,107,190 due to these exemptions.
