Park County Board of County Commissioners Special Meeting May 2, 2013

A special meeting of the Board of County Commissioners of Park County, Wyoming, was held on Tuesday, May 2, 2013. Present were Chairman Loren Grosskopf, Commissioners Bucky Hall, Lee Livingston, Joe Tilden and Tim French, and County Clerk Jerri Torczon.

Chairman Loren Grosskopf called the meeting to order and County Clerk Jerri Torczon led the audience in the Pledge of Allegiance.

Contested Case Hearing - In the Matter of the Petition of Scott Justice and Marjory Justice, et al, for the Establishment of a County Highway,

Chairman Grosskopf, acting as Hearing Officer in the Contested Case Hearing of the Petition of Scott Justice and Marjory Justice, et al., for the Establishment of a County Highway, called on James F. Davis, Deputy County Attorney, to present his case in point.

- Mr. Davis stated that this meeting was scheduled for a Contested Case Hearing, based on an Order of Reversal and Remand by District Court Judge Steven Cranfill on Stephen and Audrey Smith's appeal of Park County RESOLUTION NO. 2009-05, DISMISSING PETITION FILED BY SCOTT AND MARJORY JUSTICE, ET AL., TO ESTABLISH A COUNTY ROAD IN T.49N., R. 100 W., 6TH P.M., PARK COUNTY, WYOMING, FOLLOWING REMAND BY DISTRICT COURT. Mr. Davis stated that the Smiths, through their attorney, S. Joseph Darrah, have filed a Motion to Dismiss Without Prejudice, as they will have sold the subject property prior to the hearing and no longer have a standing in this matter. Park County has since filed an Objection to the Motion to Dismiss, as witnesses were subpoenaed to present evidence and Park County seeks to proceed with the presentation of evidence.
- Mr. Davis offered forty-five exhibits. No objections were raised to the Exhibits offered into the record.

- Mr. Davis stated that based on case law, a road is essentially where it is and used by the public, despite variations. Mr. Davis maintains that County Road 3IC is a county road and based on testimony to be presented, the road in question is still a county road, although there are discrepancies or errors in the original survey and notes. Mr. Davis stated that the original road, as established in 1902 was used by the public to travel from Meeteetse to Cody, and was used until Highway 120 came into effect in the 1920's or 1930's. That county road was the only established road between Cody and Meeteetse for decades and has never been vacated.
- Mr. Davis called Greg Meinecke, County Engineer, to testify regarding County Road 11. Mr. Meinecke stated that the road was established on September 4, 1901 by Big Horn County Commissioners, and has never been vacated. Mr. Meinecke testified as to the notes on file in his office referring to the establishment, construction and surveys of County Road 11.
- Mr. Davis called Stan Abell, Jr., Vice-President and Professional Engineer with Grosch Construction, Inc. of Worland, Wyoming. Mr. Abell testified that he has researched the issue of whether the road is a county road and has reviewed the documents from Big Horn County, the original surveyor's notes and the placement of the road. Mr. Abell testified that the original survey had inaccuracies. Mr. Abell stated that the road was legally established, was constructed by the original land surveyor, and the road built is reflected in later surveys, including the United States General Land Office Resurvey of 1905. Mr. Abell stated that County Road 11, established by Big Horn County, was used until Highway 120 was built. Mr. Abell testified as to the road locations based on Google Earth maps. Mr. Abell testified that County Road 11 was legally established, constructed and used where it physically exists on the ground and that he found no evidence that any part of it was abandoned.
- Mr. Davis called Bruce Burrows with the Wyoming Department of Transportation, Public Affairs Division. Mr. Burrows testified as to the approximate

dates of which Highway 120 was built. Mr. Burrows stated that the Highway Department was established by the State of Wyoming in 1917 and for the first two years of its existence, there was no funding or very little. Mr. Burrows stated that there were two projects funded along what is now Highway 120 in 1919-1920 and 1921-1922. From 1936-1940 additional projects were constructed further north to Cody from Meeteetse.

Mr. Davis called Richard T. Muscio, Professional Land Surveyor with GDA Engineers. Mr. Muscio testified that he was asked to look at the original survey notes to see if it could be recreated on the ground. Mr. Muscio stated that he was able to find the GPS location at one of the known points in Cody. Mr. Muscio stated that the road at one point is 600 to 700 feet off of the survey, which he did not view as being far away when you're building a road. Mr. Muscio stated that the road matches the 1911 US Geological topography sheet. Mr. Muscio testified that in his opinion Road 3IC is a county road and it is close to the original alignment as it was constructed.

Mr. Davis called Kenneth F. Tyler, Park County Engineer from 1979-1993. Mr. Tyler was the County Engineer on June 17, 1987 when he sent a letter to Larry Bates, Roy Schatz and Steven C. Smith regarding the old Cody-Meeteetse Road. Mr. Tyler testified why the letter was written and its intent to take all gates off the county road, and to install cattle-guards, pursuant to a vote of Park County Commissioners. Mr. Tyler stated that the road was a county road on the record and the removal of the gates on the road was to make the entire road open.

Mr. Davis called Scott Justice. Mr. Justice testified that he owned twenty acres on Road 3IC from 1993 to 2006. Mr. Justice stated that when he purchased the property, the title insurance referred to the county road, but that the road was referenced as 3JC. Mr. Justice stated that they used the road on a daily basis and that Park County used to plow the road and built a turn-around for the school bus. Mr. Justice stated that he never obtained permission to use the road. Mr. Justice stated that Steve Smith said it was not a county road and that is why he filed the original petition the County to make it a county road.

Mr. Davis called Roy Schatz. Mr. Schatz testified that he previously owned the place that Scott Justice owned. Mr. Schatz stated that the road was referred to a as a county road on his title insurance, on his lease with option to buy and in other correspondence, but that road referred to County Road 3JC. Mr. Schatz stated that Park County required that the gates on the road be removed after a dispute between Mr. Schatz and Mr. Smith.

Mr. Davis called Pete Moller. Mr. Moller testified that he lived in the Cody area most of his life and worked on ranches in the Meeteetse area after he got out of high school. Mr. Moller stated that he worked for Jerry Housel in 1959 irrigating and worked on the haying crew. Mr. Moller stated that he lived at what was referred to as the Foster place. Mr. Moller stated that he would use that road (Road 3IC) on a daily basis and never asked anyone permission to use the road. Mr. Moller stated that was the only access road.

Mr. Davis called Thomas Severude. Mr. Severude stated that he currently works for Park County Road and Bridge and has worked there since 2004. Mr. Severude stated that he moved to Meeteetse in 1980 and worked on the Nielson Ranch as foreman. Mr. Severude stated that they would use Road 3IC to access the ranch. Mr. Severude stated that Jack Winninger, a former County Commissioner, referred to it as a county road and would have it bladed before haying season each year. Mr. Severude testified that he bladed that road once a year as a County employee and when it became part of litigation, he was told to stay off the road. Mr. Severude stated that some of the maps Jerry Housel had showed a county right-of-way. Mr. Severude stated that Mr. Smith did not come out and say that it was not a county road. Mr. Severude stated that Road 3IC was labeled as Road 3JC at some point in time.

Mr. Davis called Shane Scott. Mr. Scott testified that he lives in Meeteetse and worked for Park County Road and Bridge beginning in 1989 and worked for eighteen months in the Meeteetse area. Mr. Scott stated that he is familiar with the road referred to as County Road 3IC and used to maintain that road. Mr. Scott testified that the county did do work on the road with a D7 and back sloped the area

to ease the grade. Mr. Scott stated that they would also plow the road on behalf of Park County.

No further testimony was received. Mr. Davis concluded that the road is a county road and stated that the evidence does show it is a county road. Mr. Davis will prepare the proposed findings of fact and conclusions of law for the Board's review.
