# Park County Board of County Commissioners Regular Meeting June 18, 2013

A regular meeting of the Board of County Commissioners of Park County, Wyoming, was held on Tuesday, June 18, 2013. Present were Chairman Loren Grosskopf, Commissioners Bucky Hall, Lee Livingston, Joe Tilden and Tim French, and County Clerk Jerri Torczon.

Chairman Loren Grosskopf called the meeting to order and Mark Heinz of the Cody Enterprise led the audience in the Pledge of Allegiance.

#### Public Hearing - Liquor License Renewals.

Chairman Grosskopf opened the public hearing on Park County's twenty-four liquor license renewal applications for the license term of July 25, 2013 through July 24, 2014. County Clerk Jerri Torczon reported that no written comments or objections were received, but did inform the Board that Powell Country Club is not in compliance with State requirements at this time. Questions were raised on the liquor license renewal for Jon Sowerwine, d.b.a. Wapiti. It was reported that the new building will be started on July 1, 2013 and should be completed in September. There were no other public comments put forth from the audience. It was moved by Commissioner Tilden, seconded by Commissioner French and unanimously carried to close the public hearing.

# Public Hearing – Review Floodplain Permit Application of Sandra Whalen.

Chairman Grosskopf opened the public hearing to review the Floodplain Permit Application of Sandra Whalen to place an accessory structure (garage) within the special flood hazard area at 31 Creek Lane, Cody, in the N2SW4 Lot 44, T52N R101W, 6th PM, Park County, Wyoming. Linda Gillett, County Planner, presented the staff report and answered questions of the Board. No other comments were

presented. It was moved by Commissioner French, seconded by Commissioner Tilden and unanimously carried to close the public hearing.

# Approval - Final Plat Review of Gould Simple Subdivision.

Becky Ross, Planner II, came before the Board and presented the staff report on the Gould Simple Subdivision, 218, Partial Vacation and De-Annexation. After a general discussion, it was moved by Commissioner Livingston, seconded by Commissioner Tilden and unanimously carried to approve **RESOLUTION 2013-27**, REPORT OF IMPACT K AND B LLC DE-ANNEXATION FROM THE TOWN OF MEETEETSE and to approve **RESOLUTION NO. 2013-28**, FINAL PLAT APPROVAL OF GOULD SIMPLE SUBDIVSION - 218.

# **Shoshone National Forest Fuels Treatment**.

Paul Flanagan, Acting Director, and Clint Dawson, Assistant Forest Fire Management Officer for the Shoshone National Forest, came before the Board and gave a PowerPoint presentation on the fuels treatment within the forest. It was reported that over 500,000 acres of forest have been affected by the pine beetle, and the Forest Service is attempting to manage the fuels before a forest fire starts by conducting prescribed burns, with timber sales and with mechanical treatment,

#### **Appointment - Park County Museum Board.**

Interviews were scheduled for two appointments to the Park County Museum Board. No interviews were conducted, due to illness of one applicant and the other applicant being an incumbent. Following a general discussion, it was moved by Commissioner Hall, seconded by Commissioner Livingston and unanimously carried to appoint Linda Orrell of the Meeteetse School District to a three year term on the Park County Museum Board and to reschedule the interview of Phyllis Miller, who applied from the Powell School District.

# **Executive Session.**

It was moved by Commissioner Hall, seconded by Commissioner French and unanimously carried to go into Executive Session regarding potential litigation, pursuant to Wyoming Statute §16-4-405(a)(iii).

It was moved by Commissioner Hall, seconded by Commissioner Tilden and unanimously carried to go out of Executive Session.

# Approval - Final Plat Review for Savage Minor Subdivision-15.

Becky Ross, Planner II, came before the Board and presented the staff report of the Savage Minor Subdivision-15. Following a general discussion, it was moved by Commissioner Livingston, seconded by Commissioner Tilden and unanimously carried to approve **RESOLUTION NO. 2013-29**, APPROVAL OF THE FINAL PLAT OF SAVAGE MS-15.

# **Approval - Discussion of Audit Bid.**

Chairman Loren Grosskopf reported that Joseph Eve, the County's Auditor, has submitted formal notification that their firm is unable to perform the audits for 2013 and 2014. Following a general discussion, it was moved by Commissioner Hall, seconded by Commissioner Tilden and unanimously carried to advertise for proposals, with proposals being submitted by July 15, 2013 and acceptance of bids at the July 16, 2013 meeting.
