June 24, 2013**

### **Preliminary Budget Review.**

The Board conducted budget review sessions with the Library Board, the County Engineer, and the Fair Board. Discussion was held regarding cash carry-over amounts for the four boards, pay increases for certain positions and employees, payment of the increase in Wyoming Retirement, of a one-time salary adjustment for employees and withdrawing \$250,000.00 from the Health Insurance Fund. Further discussion on the budget will be held July 2, 2013.

### **Public Hearing - Budget Amendment.**

A public hearing to amend Fiscal Year 2012-13 budget was advertised. County Clerk Jerri Torczon reported that there were three departments that exceeded budgeted amounts. However, the County Attorney advised that no public hearing was necessary as the total County budget was not over-expended. Budgets that

exceeded their line item budgets were District Court, which spent \$13,903.80 more than anticipated; Public Health Emergency Preparedness, which spent \$7,536.41 more than anticipated; and Health Officer, which exceeded \$8,720.92 more than anticipated.

**Adjournment.**

It was moved by Commissioner Hall, seconded by Commissioner Tilden and unanimously carried to adjourn the meeting.
