# Park County Board of County Commissioners Regular Meeting April 15, 2014

A regular meeting of the Board of County Commissioners of Park County, Wyoming, was held on Tuesday, April 15, 2014. Present were Chairman Bucky Hall, Commissioners Loren Grosskopf, Lee Livingston, Joe Tilden and Tim French, and County Clerk Jerri Torczon.

Chairman Hall called the meeting to order and led the audience in the Pledge of Allegiance.

#### **Approval - Letter to Northwest Rural Water District.**

Greg Meinecke, County Engineer, came before the Board and presented a letter to Northwest Rural Water District regarding issues with the contractor on the North End Waterline Project and the Right-of-Way Permit. Five items of violation were outlined in the letter. It was moved by Commissioner Livingston, seconded by Commissioner Tilden and unanimously carried to approve the letter. Commissioner Livingston was not present for the remainder of the morning meeting.

#### Recess.

The meeting recessed for a staff meeting and a Worksession in the Old Law Library with the County Clerk and Treasurer regarding the audit.

#### Cowboy & Cowgirl Ambassador Update.

Ray and Jackie Maple, a.k.a. Tom O'Day and Bronco Nell, came before the Board and presented an update regarding their Cowboy & Cowgirl Ambassador activities. They also introduced Marlin Yorty, a.k.a. Kid Currey. It was reported that they have targeted most of their presentations at senior centers and retirement homes. They will be doing a presentation at the Hyart Theater in Lovell as part of a fund riser for the Kane Museum and they are planning a trip to Pennsylvania next year. They have represented Cody and Park County a great deal throughout the year. The Commissioners thanked Ray, Jackie and Marlin for their continued efforts and activities in supporting Park County as the Cowboy and Cowgirl Ambassadors.

### Public Health Monthly Update.

Bill Crampton, Public Health Nurse Manager, came before the Board and presented the Public Health Monthly Update. It was reported that the number of contacts with new parents has gone down due to an increase for nurse midwives. Attempts to contact nurse midwives will be made to inform them of services provided by Public Health.

#### Approval - Funding Request for World War I State Memorial.

Buck Wilkerson, representing the Wyoming Veterans Memorial Park, came before the Board and requested a contribution to the World War I State Memorial that will be completed in May. The Commissioners approved \$5,000.00 in funding for construction on the Wyoming Korean War Veterans Memorial, \$10,000.00 for the Wyoming State Vietnam War Memorial and \$10,000.00 for the World War II Memorial. It was moved by Commissioner Grosskopf, seconded by Commissioner Tilden and unanimously carried to approving funding for the World War I State Memorial, in the amount of \$10,000.00.

### <u>Discussion - Wyoming Department of Health Request for Park County Commissioner to serve on Select Committee.</u>

A discussion was held on whether to appoint a Commissioner to serve on the Select Committee of the Wyoming Department of Health, Behavioral Health Division, regarding substance abuse treatment services in Hot Springs County. It appears that Park County is not an affected County as part of that process, and the consensus of the Board was not to appoint a Commissioner to this Committee.
