

**Park County Board of County Commissioners
Regular Meeting
September 2, 2014**

A regular meeting of the Board of County Commissioners of Park County, Wyoming, was held on Tuesday, September 2, 2014. Present were Chairman Bucky Hall, Commissioners Loren Grosskopf, Lee Livingston, Joe Tilden, and Tim French, and County Clerk Jerri Torczon.

Chairman Hall called the meeting to order and led the audience in the Pledge of Allegiance.

Approval - Transportation Study Grant Sponsorship Request.

Christine Bekes, Executive Director of the Powell Economic Partnership, and James Klessens, CEO and President of Forward Cody Wyoming, Inc., came before the Board and requested approval of the sponsorship for a Transportation Study Grant to determine the feasibility of public transportation in Park County. The Wyoming Department of Energy is offering \$90,000.00 in grants, with the maximum grant amount to be \$30,000.00, with a local match of \$3,000.00. The deadline for the grant application is November 15, 2014. After a general discussion, it was moved by Commissioner Tilden, seconded by Commissioner Grosskopf and unanimously carried to approve the sponsorship for the Transportation Study Grant, with Park County being the pass through agency, as long as there is no financial liability to Park County.

Air Transportation Liaison Committee Report.

Chairman Bucky Hall called on Bob Hooper, Chairman of CY Air, and Senator Hank Coe, Chairman of the Wyoming Legislature Air Transportation Liaison Committee, to give an update of the meeting they attended last week in Jackson regarding the airline industry. The new pilot flight rules that were amended in 2009 are severely affecting the industry, in that pilots are now required to have 1,500 hours rather than 250 of flight hours previously required, which is resulting in a severe pilot shortage. The airline industry is also seeing a decrease in the number of airplanes being built for small commuter airports. It was reported that 110 communities nationwide have lost air service, including Topeka, Kansas. Sky West has made it very clear that they will not be opening new routes. The Cody Regional Airport is still strong and generates \$40,000,000.00 to the local economy. Comments were also received from James Klessens and Craig Wilbur, members of CY Air, and Rick Patton of GDA Engineers, reflecting on the importance of air flights in and out of Cody.

Discussion – Four County Meeting Report.

Commissioner Grosskopf and Commissioner Tilden attended the four county meeting in Worland last week and gave a brief report. The four counties are Park County, Big Horn County, Washakie County and Hot Springs County. A large part of the discussion regarded the Waters of the US Issue and the term "navigable" waters as used in the Environmental Protection Agency rules. The final Bureau of Land Management Resource Management Plan will not be available until late fall or early spring. A discussion was held regarding Cloud Peak Counseling implementing more secure bedding that would allow for the expansion of their facilities for Involuntary Hospitalization Commitments rather than sending patients to Casper or Evanston. A discussion was also held regarding closure of the South Big Horn County landfill.

Approval of Minutes.

The minutes of the regular meeting of August 19, 2014 and the special meeting of August 25, 2014 were presented to the Board for consideration. It was moved by Commissioner Tilden, seconded by Commissioner Livingston and unanimously carried to approve the minutes as presented.

Approval of Payroll.

Payrolls for August 19, 2015, in the amount of \$1,644.96; for August 21, 2014, in the amount of \$437.46; and for August 28, 2014, in the amount of \$536,995.01, were presented to the Board for consideration. It was moved by Commissioner

French, seconded by Commissioner Grosskopf and unanimously carried to approve the payrolls as presented.

Approval of Vouchers.

Special Funding Request Contracts.

Deputy Clerk Teecee Barrett presented the Special Funding Contracts for the Board's consideration. It was moved by Commissioner Grosskopf, seconded by Commissioner French and unanimously carried to write the Fair Board a letter requesting an update at the September 16th meeting

Approval - Request to City of Powell to Waive Construction Fees.

Commissioner Grosskopf requested that a letter be sent to the City of Powell asking them to waive construction fees for the Multi-Purpose Building at the Fairgrounds. It was moved by Commissioner Grosskopf, seconded by Commissioner Tilden and unanimously carried to write a letter to the City of Powell asking that they waive construction fees.

Recess for Lunch.

The meeting recessed for lunch and reconvened at 1:00 p.m.

Public Hearing - Amending the Fiscal Year 2014-15 Park County Budget.

Chairman Bucky Hall opened the public hearing on Amending the Fiscal Year 2014-15 Park County Budget. County Clerk Jerri Torczon presented the proposed changes as requested by the Commissioners where the four Boards, the Fair Board, the Library Board, the Museum Board and the Parks and Recreation Board, be

treated as one department in the budget document. No comments were received from the audience. It was moved by Commissioner Tilden, seconded by Commissioner Grosskopf and unanimously carried to close the public hearing.

Approval - Resolution Amending the Fiscal Year 2014-15 Park County Budget.

It was moved by Commissioner French, Seconded by Commissioner Tilden and unanimously carried to approve **RESOLUTION NO. 2014-38**, A RESOLUTION AMENDING THE FISCAL YEAR 2014-15 PARK COUNTY BUDGET.

Approval - Partial Vacation and Amended Plat Review for Simple Subdivision-16.

Becky Ross, Planner II, and Linda Gillett, Planning & Zoning Director, came before the Board and presented the Staff Report and Findings of Fact, Conclusions and Recommendations on the application of Jerry S. Faxon to vacate and amend the existing plat for SS-16, Lot 1-A, to adjust the boundary with an adjacent unplatted parcel relocating the southern boundary to the centerline of road 6, relocating eastern property line to extend southeasterly to follow the edge of an existing agricultural field to Road 6, and relocating the northern boundary line south 114.7 feet, with the result lot being renamed to Lot 1-B, 8.57 acres. It was moved by Commissioner Tilden, seconded by Commissioner Livingston and unanimously carried to approve **RESOLUTION NO. 2014-39**, APPROVAL OF THE PARTIAL VACATION AND AMENDED PLAT OF SS-16, LOT 1-A.

Update - Search & Rescue Building.

Commissioner Livingston said he is waiting for some preliminary information from Rick Lambert and the update will be given at the next Commissioner meeting.

Bid Opening - Fairgrounds Building Construction.

Dan Odasz of Plan 1 Architects and Dennis Spargur, Maintenance Manager, came before the Board and conducted the Bid Opening for the Park County Fairgrounds Building Construction Project. Bids were received from KWM Construction of Sheridan, in the amount of \$2,584,000.00, with a bid of \$93,400.00 for Alternate #1, and a bid of \$45,100.00 for Alternate #2; from Wright Brothers of Sheridan, in the amount of \$3,069,340.00, with a bid of \$119,035.00 for Alternate #1, and a bid of \$44,977.00 for Alternate #2; from Diamond Point Construction of Cody, in the amount of \$2,842,000.00, with a bid of \$132,000.00 for Alternate #1, and a bid of \$47,000.00 for Alternate #2; from Synergy Construction of Lovell, in the amount of \$2,556,000.00, with a bid of \$103,000.00 for Alternate #1, and a bid of \$46,000.00 for Alternate #2; from Filener Construction of Cody, in the amount of \$2,803,000.00, with a bid of \$89,000.00 for Alternate #1, and a bid of \$58,000.00 for Alternate #2; and from GH Phipps of Laramie, in the amount of \$2,918,000.00, with a bid of \$133,00.00 for Alternate #1, and a bid of \$71,200.00 for Alternate #2. Bids will be reviewed with a recommendation to be made at the next meeting.
