#### Park County Board of County Commissioners Regular Meeting November 18, 2014

A regular meeting of the Board of County Commissioners of Park County, Wyoming, was held on Tuesday, November 18, 2014. Present were Chairman Bucky Hall, Commissioners Loren Grosskopf, Lee Livingston, Joe Tilden, and Tim French, and County Clerk Jerri Torczon.

Chairman Hall called the meeting to order and County Clerk Jerri Torczon led the audience in the Pledge of Allegiance.

### Approval - Reconsideration of Condition #6 on Resolution No. 2010-40 to Install Public Water for Simple Subdivision.

Linda Gillett, Planning & Zoning Director, came before the Board and presented the staff report on the Request of Robert T. Willey for Reconsideration of Condition #6 on Resolution No. 2010-40 to Install Public Water for Simple Subdivision The final plat was never recorded due to the condition on the plat that public water be installed to a 33-acre parcel that is agricultural and the costs associated with boring under the highway. Water is available to the adjacent 6-acre lot. Linda Gillett and Robert Willey answered questions of the Board. Mary McKinney of the Park County Weed & Pest Board reported that the long-term noxious weed control plan would still be a condition of the final plat. After a general discussion, it was moved by Commissioner French, seconded by Commissioner Tilden and unanimously carried to approve **RESOLUTION NO. 2014-51**, APPROVAL OF WILLEY RECONSIDERATION OF RESOLUTION 2014-40 REQUIREMENT FOR PUBLIC WATER.

# Approval - Winchester Major Subdivision Phase One Final Plat.

Linda Gillett, Planning & Zoning Director, came before the Board and presented the staff report and answered questions on the Winchester Major Subdivision Phase One Final Plat. It was moved by Commissioner Livingston, seconded by Commissioner Tilden and unanimously carried to approve **RESOLUTION NO. 2014-52**, WINCHESTER MAJOR SUBDIVISION PHASE ONE FINAL PLAT APPROVAL.

# Public Hearing – Application of 2Visions, LLC for a Minor Subdivision.

Chairman Hall opened the public hearing on the application of 2Visions, LLC for a minor subdivision consisting of four (4) lots, three lots of 8.96 acres and one lot of 12.67 acres, located on the Southfork Highway between Lonetree Lane and Douglas Drive, within Pt. of Lot 44-20 and 43-A (RS) T.52N., R.102W., 6th P.M., Park County, Wyoming on a General Rural 5-acre (GR-5) zoning district. Linda Gillett, Planning & Zoning Director, presented the staff report and answered questions of the Board. Comments expressing concern were made at the Planning & Zoning meeting on September 16, 2014 regarding the poor condition and maintenance of Lonetree Lane (access to Lots 2 and 4); the safety of access from the Southfork Highway onto Lonetree Lane and Douglas Drive, and about the irrigation and noxious weeds. Comments were received from Michael LaBazzo, representing neighbors Bill and Virginia Bien and Steve Poley, regarding the safety and condition of Lonetree Lane. Mary McKinney of Park County Weed & Pest spoke regarding the noxious weed control program. Comments were received from Rob Overfield of Engineering Associates, representing the applicant. Following a general discussion, it was the consensus of the Board to continue the public hearing until December 16, 2014 at 1:00 p.m. to allow time to evaluate the possibility of access off of Douglas Drive for all four lots.

### <u>Approval - Boundary Line Adjustment to Combine Seven Lots in Squaw Creek</u> <u>Subdivision.</u>

Linda Gillett, Planning & Zoning Director, came before the Board and presented a request for boundary line adjustments, vacating Lots 12 through 18 to create Lot 112 within the Squaw Creek Subdivision located in Homestead Entry Survey No. 176, Park County, Wyoming. It was moved by Commissioner French, seconded by Commissioner Tilden and unanimously carried to approve **RESOLUTION NO. 2014-53**, APPROVAL OF THE MINOR BOUNDARY LINE ADJUSTMENT COMBINING LOTS 12 THROUGH 18 WITHIN SQUAW CREEK SUBDIVISION.

#### Bid Opening - Roll-Off Services at Landfills (3) and Crandall Transfer Station.

Tim Waddell, Solid Waste Manager, and Sandie Morris, Solid Waste Office Manager, came before the Board and conducted the bid opening for roll-off services at the three landfills and the Crandall Transfer Station. # Public Health Nurse Manager Monthly Update.

It was reported that the number of vaccines and flu shots given by Public Health has increased dramatically because the Powell Hospital did not receive their flu vaccines. Nursing students have been assisting the Public Health and will also help with the Health Fair.

Bill Crampton, Public Health Nurse Manager, presented the Wyoming Department of Health Interagency Agreement for Public Health Nursing.
