Park County Board of County Commissioners Regular Meeting June 7, 2016

Chairman French called to order a regular meeting of the Board of County Commissioners of Park County, Wyoming, on Tuesday, June 7, 2016. Present were Chairman Tim French, Commissioners Lee Livingston, Bucky Hall, Loren Grosskopf, Joe Tilden, and County Clerk Colleen Renner.

Commissioner Livingston led the audience in the Pledge of Allegiance.

Approve PT Custodian and Tech I Job Descriptions

Events Coordinator Echo Renner requested approval for position descriptions for two positions that are moving to the Events Department from Buildings and Grounds. Renner modified the existing Buildings and Grounds position descriptions to include added responsibilities. Commissioner Grosskopf asked that the proposed title of Grounds Manager (Tech I in current role) be changed. After discussion, it was decided to change to title to Grounds Foreman. Two part time custodian positions were also moved to Events. Buildings and Grounds will provide coverage for these employees in emergency situations. Renner discussed allowing one seasonal employee to operate county equipment at the fairgrounds. The commissioners asked Mike Garza, Buildings and Grounds Superintendent, to ensure the seasonal employee is certified to operate both a forklift and skid steer. A motion was made by Commissioner Tilden to approve the Events Department position descriptions with the change from Manager to Foreman, seconded by Commissioner Livingston and unanimously carried.

Executive Session.

Commissioner Tilden moved to go into executive session pursuant to Wyoming State Statute 16-4-405 (a) (ix), seconded by Commissioner Livingston and unanimously carried. No decisions were made in this session. Commissioner Hall moved to exit executive session, seconded by Commissioner Grosskopf and unanimously carried.

<u>Public Hearing- Continuation of May 17 Public Hearing: Redemption Life Center Special Use Permit 150</u>

Chairman French opened the Public Hearing continued from May 17 to consider the approval of a Special Use Permit (SUP-150) to allow a minor (small) institutional use (group home) housing up to eight people in a residential half acre (R-H) zoning district. The property's legal description is 5 acres in Sec. 3, T52N, R102W, 6th PM, Park County, Wyoming; the address is #6 Agua Via Lane, Cody. The Chairman called on those who wished to address the Board. Many reiterated the same concerns expressed in the prior meeting. French emphasized the complexities of the issues the Board must consider in its decision, such as fair housing laws. The Board's decision will come at a later date, still to be determined. Commissioner Hall made a motion to close the public hearing, seconded by Commissioner Tilden and unanimously carried.

Approve Revised Park County Socioeconomic Profile

Gregory Cowan, WCCA Natural Resource Staff Attorney and David (Tex) Taylor, Project Lead / UW Professor joined the Board via phone. Additions to the study requested by the commissioners included household income; transfer payments; oil and gas defined separately from mining; benefits and average wages for county and commercial ag. The State A & I prompted additional reference changes. Commissioners feel the study

provides a very thorough reference to help us in the future. Commissioner Grosskopf asked how many other Wyoming counties are having the study compiled. Taylor said Park County is the third with four more counties also expressing interest. Commissioner Grosskopf made a motion to approve the revised Park County Socioeconomic Profile, seconded by Commissioner Tilden and unanimously carried.

Budget Discussion

Commissioner French asked the Board to discuss how to address next year's budget deficit. Commissioners noted that County departments have made cuts over the past five years and some departments have no ability to reduce further. The Board plans to use some of the County's reserves but will also ask departments to cut an additional five percent from next year's budgets. The Board will have individual budget meetings with each department at the end of the month.

Payment of Wyoming County Commissioners' Association

The Board considered approval of annual WCCA dues. With WCCA's implementation of a new formula using different criteria to determine counties' allocations, the dues have been reduced \$2,029.00 from last year. Commissioner Hall made a motion to pay the dues in the amount \$17,261.00, seconded by Commissioner Livingston and unanimously carried.

Convene as Board of Equalization

Pat Meyer, County Assessor, met with the board to discuss scheduling the hearings for tax appeals. The commissioners set the hearing date at August 23, 2016, beginning at 8 a.m.

Pat Meyer recommends that the board appoint Sox Freeman as hearing officer. Meyer will find a court reporter. Commissioner Tilden moved to appoint Sox Freeman as the hearing officer, seconded by Commissioner Hall and unanimously carried. Meyer will send the commissioners the new laws/rules of the guidelines, which include the requirement to deliberate in public. Commissioner Tilden made a motion to adjourn as Board of Equalization, seconded by Commissioner Hall and unanimously carried.

Approve-Minutes.

The minutes from the regular Board meeting of May 17 were presented to the Board for approval. Commissioner Tilden moved to approve the minutes with corrections, seconded by Commissioner Livingston and unanimously carried.

Approve-Payroll.

Payroll was presented to the Board for approval. Commissioner Livingston moved to approve payroll as presented, seconded by Commissioner Tilden and unanimously carried.

Approve-Vouchers.

Three contracts: Public Health Nursing Services, Public Health Emergency Preparedness Unit, and Public Health Officer contracts were presented for approval. Changes were made in the contracts and sent to the county attorney for approval and signage. Commissioner Hall made the motion to approve these contracts and allow the Chair to sign, seconded by Commissioner Livingston and unanimously carried.

Approve Payment to Montana State University for Park County Transportation Feasibility Study

Commissioner Tilden made the motion to approve this payment and allow the Chair to sign, seconded by Commissioner Hall and unanimously carried.

Approve Payment to City of Cody for Park County's portion of the 1% Sales Tax Survey

Commissioner Hall made the motion to approve these contracts and allow the Chair to sign, seconded by Commissioner Livingston and unanimously carried.

Request for Approval to Advertise of Library & Museum Board Positions

Commissioner Hall made the motion to advertise for the board positions on June 9 and 13 with interviews to be held at the first meeting in July. Seconded by Commissioner Grosskopf and unanimously carried.

Approve and Sign Lease Agreement Renewals

Shaunna Romero presented the commissioners with the Lease agreements for Park County Court Supervised Treatment Program and Basin Authority which expire the end of June. The contracts were sent to the county attorney for approval, the only change in the agreements was an increase of 2.4%. Pending his approval Commissioner Tilden made a motion to approve the lease agreements, seconded by Commissioner Livingston and unanimously carried.

Approve Distribution to Local Government Cooperating Agency Counties

Added for approval was approval to refund remaining Land & Environment Funds to the four LGCA counties. Big Horn, Hot Springs, and Park counties will each receive \$50,000; Washakie will receive \$25,000. Shaunna Romero, Commissioner's Assistant, will submit vouchers for the distributions.

Approval of Ambrogi-Hartung Minor Subdivision Final Plat Review

Kim Dillivan, Planner II, presented for consideration the final plat review of Florence and Eugene Hartung, to create a minor subdivision intended for single family

residential use consisting of two lots: one lot of 7.91 acres and one lot of 3.03 acres. Legal Description: Current lot 3 (10.94 acres) of Claus No. 1 Subdivision located in Lot 44, T52N, R102W, 6th PM, Park County, Wyoming. Location: Approximately six miles southwest of Cody on the Southfork Road. Address is 665 Southfork Road (Hwy 291). Proposed Lot 1 has an existing residence. Proposed Lot 2 will also be for residential use. Commissioner Grosskopf commented that this is in a General Rural 5-acre zoning district (GR 5) and the landowners cannot subdivide the remaining 7.9 acres.

Request for Authorization to Hire (replacements of existing positions)

adequately. Commissioner Tilden made a motion to hire a replacement and allow an overlap period of three weeks, with one as a contract employee, seconded by Commissioner Grosskopf and unanimously carried.

Bryan also requested filling the Victim Witness Coordinator position. Wages for this position are fully grant-funded. Commissioner Hall made a motion to allow hiring for this position, seconded by Commissioner Grosskopf and unanimously carried.

Approve Final Health Plan Stop-loss Coverage

Eric Deeg, President/Sr. Consultant for USI Northwest joined the meeting via phone to provide explanation of the final health plan stop-loss coverage recommendation. Deeg recommended a zero increase over the next year with the counties insurance plan.

Commissioner Livingston made a motion to accept renewal from ASG and MedEx, and to authorize the Chairman to sign the application. The motion was seconded by Commissioner Hall and unanimously carried.

Barb Poley, Treasurer, and Carrie Reed, First Deputy Treasurer, opened the audit proposals that were submitted. Auditors were asked to submit bids that would encompass the next three fiscal years. Bids were as follows:

Sharon Smith, representative for the Cody Heritage Museum, presented a draft plan for a garden next to the Heritage Museum. The proposed garden would include donated artifacts and native plants. The Museum plans to involve master gardeners in the selection and care of the plants. After discussion about possible vandalism, the placing of a fence and who will maintain the area, Commissioner Tilden made a motion to approve the concept with the condition that Smith come before the Board again at a later date for final approval. Seconded by Commissioner Livingston and unanimously carried.

<u>Discussion: Consider Big Horn County's request for a letter of support from the Board of County Commissioners to obtain a gravel permit from BLM for lands within Park County (Section 11, T52N, R100W)</u>

Big Horn County has requested a letter of support from Park County to obtain a BLM gravel permit on Park County lands, located off the old Byron Road at Eagle Pass. The Board supports Big Horn County in its request, but would also like to be a permittee in the area. Commissioner Hall made a motion to provide a letter of support to Big Horn County for its permit application with request to allow Park County access to the pit if the needed arises. Seconded by Commissioner Tilden and unanimously carried.
