Approve-Budget Amendments for FY 2016.

Colleen Renner, County Clerk, presented the estimated final budget amendments to include the final payroll to be processed in FY2016. The budget amendments were reported only for departments over on the bottom line of their budget; most overages were due to payroll entry errors when the original budget was input. After general discussion Commissioner Hall moved to approve the budget amendment in the amount of \$467,609.30, and any additional end of year expenditures changes, for the final resolution on July 5, 2016. The motion was seconded by Commissioner Grosskopf and carried

three to one with Commissioner Grosskopf voting opposed after further discussion.

Budget Discussion-Continued.

There was general discussion on possible step and grade increases. It was the general consensus that not all departments were aware requests could be submitted so the discussion will be postponed until the first meeting in July.

Brian Edwards, County Engineer, proposed that the moneys taken out of the CRF fund for the Andy Martin Hill project be returned to the fund since Consensus Funds have since paid for the project (approximately \$242,928.00). Further discussion on CRF funds continued; the Board decided not to use those funds on road materials this year, and to add the \$350,000.00 back into the regular road materials line item.

Executive Session.

Commissioner Livingston moved that the Board go into executive session pursuant to Wyoming State Statute 16-4-405 (a) (ii), seconded by Commissioner Tilden and unanimously carried. No decisions were made in this session. Commissioner Hall moved to exit executive session, seconded by Commissioner Livingston and unanimously carried. Commissioner Hall moved to rescind the June 21 motion for the pay options for exempt employees and instead pay them the 27th pay period, seconded by Commissioner Tilden and unanimously carried.

<u>Adjourn</u>

Commissioner Hall made a motion to adjourn, Commissioner Livingston seconded and the motion carried.
