## Park County Board of County Commissioners Regular Meeting

Tuesday, January 8, 2019

Vice Chairman Jake Fulkerson called to order a regular meeting of the Board of County Commissioners of Park County, Wyoming, on Tuesday, January 8, 2019. Also present were Commissioners, Dossie Overfield, Lloyd Thiel and Joe Tilden, and First Deputy County Clerk Hans Odde. Commissioner Lee Livingston was absent.

City of Cody Mayor Matt Hall led the audience in the Pledge of Allegiance.

Vice Chairman Fulkerson welcomed the two new board members to their first official meeting of the Board of County Commissioners.

#### Commissioners RE: Election of 2019 officers

Commissioner Tilden made a motion to appoint Commissioner Fulkerson as Chairman of the Park County Commission. Commissioner Thiel seconded and the motion carried.

Commissioner Overfield made a motion to appoint Commissioner Tilden as Vice Chairman of the Park County Commission. Commissioner Thiel seconded and the motion carried.

Commissioner Tilden made a motion to appoint Dr. Aaron Billin, MD as the Park County Health Officer. Commissioner Overfield seconded and the motion carried.

#### **RE: Latimer Appeal of Small Waste Water Violation**

Park County Planner Joy Hill summarized the violations that she cited Dan Latimer dba DW Latimer Excavation for regarding Mr. Latimer's failure to acquire a permit to install a small waste water treatment system in November of 2018 for Patrick and Deborah Montgomery. Ms. Hill stated that Mr. Latimer had been warned in the past that he was in violation on other projects that he did not obtain permits for and has a history of avoiding the regulations. Ms. Hill issued a "notice of violation" on November 14, 2018 citing Mr. Latimer for two days of violations at \$750 per day and a \$100 investigative fee for a total of \$1.600.

Mr. Latimer is appealing the notice of violation and fine and stated that he felt that he wasn't doing anything illegal as he had an emergency with impending bad weather and had broken ground and placed the septic tank in the interest of saving time before obtaining the permit. Mr. Latimer stated that the Montgomery's were in the process of moving their home due to a geological shift in the mountain and also needed to relocate the septic system. Commissioner Thiel asked Mr. Latimer how long he knew that he was going to need a permit. Mr. Latimer responded saying that work on the project had been ongoing for several months. Commissioner Overfield asked if Mr. Latimer knew if the owners had a building permit and he responded that he did not know.

Commissioner Thiel asked Ms. Hill if Mr. Latimer had any violations related to his work and she stated that he seems to be a very competent installer and he had not had any work related violations.

After further discussion Commissioner Tilden made a motion to deny Dan Latimer's appeal and uphold the Park County Planning Director's Notice of Violation to Dan Latimer for failure to obtain a Small Waste Water System permit in a timely fashion and reduce the fine from \$1,600 to \$100. Commissioner Thiel seconded and the motion carried. **Resolution 2019-02**
