Kim Dillivan, Planning & Zoning - RE: Riverside MS-60 SIA and Final Plat

Mr. Dillivan presented the applicants request for approval of the final plat for a five-lot subdivision consisting of five 4.0-acre lots. The owners Arnold & Vicki Mollet are also requesting approval of the Subdivision Improvements Agreement and Escrow Agreement. Attorney Skoric granted approval of the Escrow Agreement and requires the Boards approval of the bank selection.

The location is two miles southwest of Ralston in GR-P zoning and currently vacant land surrounded by residential and residential vacant. The subdivision is not within one mile of municipalities, no public hearing is required, and no public comments were received.

<u>Brian Edwards, Public Works Department – RE: Review bids and consider staff recommendation for purchase of track hoe excavator(s) for Public Works Department</u>

Mr. Edwards stated Tristate loaned a Volvo for employees in road and bridge and landfill to operate the excavator before a decision was made. After discussion Mr. Edwards recommends purchasing the smaller Volvo 160 from Tristate for \$189,664 and regroup after the compactor comes the end of January to decide on the purchase of the other track hoe for Landfill.

Commissioner Livingston made a motion to proceed with staff recommendation, Commissioner Tilden seconded, motion carried.
