The Upper Southfork Area Comprehensive Policy Statement shall be used as guidance in the development of other elements of the Comprehensive Plan for Park County and shall not be used to review land use classifications, reclassifications, planned unit developments, and subdivisions unless the Upper Southfork Area comprehensive Policy Statement is endorse by the Board of County Commissioners pursuant to the "Park County Development Standards and Regulations".

INIKUDUCTION

Planning is essential to the efficient operations of both government at enterprises. It is especially important in Park County to manage change ... ough planning. Recognizing the changes and choices confronting Park County, the Park County Planning and Zoning Commission has adopted these principles to guide planning within the Upper Southfork Area.

The Comprehensive Policy Statement (CPS) is advisory in nature. When used in evaluating specific actions or proposals, the CPS is intended to provide guidance. The CPS does not exclude consideration of actions or proposals which were not anticipated by the CPS.

The Local Area CPS is intended to do the following:

- (1) Provide direction for elected and appointed officials as to the community's desires.
- (2) Enable the county and others to anticipate the community's desires for public services and facilities, type and intensity of development, and public participation in the decision-making process.
 - (3) Make the best use of the community's natural resources.

(4) Encourage a well-balanced, prosperous economy.

- (5) Enhance the community's unique character, customs, culture, traditions, and quality of life, and protect the community's natural environment pursuant to their stated goals and objectives.
- (6) Act as a guide to decision makers in reviewing development proposals and actions concerning the community.
- (7) Provide coordination of the use of resources in areas of diverse ownership.

This CPS applies to the unincorporated areas of Park County within the Upper Southfork Planning Area, and includes a number of components which address particular issues such as land use, the economy, public facilities, natural resources, and the local customs and culture.

At times, the CPS may need to be amended as the Upper Southfork Area's desires or factors affecting the Upper Southfork Planning Area change. Park County anticipates using Local Citizen Advisory Committees to recommend changes to the CPS as needs are identified by citizens of the Upper Southfork Area or elected and appointed officials.

AUTHORITY

Title 18, Chapter 5 and Title 9, Chapter 3 of the Wyoming State Statute provide the authority for and detail the scope and purpose of plans for countles or portions of countles.

Encourage the protection and enhancement of migration routes, green belts, wetlands, winter range.

OBJECTIVE #2 USEN:

Curtall the introduction and spread of undesirable plants and weeds.

OBJECTIVE #3 USEN:

Maintain a well-balanced environment for wild and domestic animals, and acceptable plant communities by applying the concept of multiple use.

OBJECTIVE #4 USEN:

Protect visual qualities and ridgelines of the area.

OBJECTIVE #5 USEN:

Keep humans in the equation.

OBJECTIVE #6 USEN:

Encourage ranching and other agricultural and recreational use of land to prevent the break up and sale of large parcels.

OBJECTIVE #7 USEN:

Maintain a rural environment for the Upper Southfork, utilizing our traditional agricultural, established outfitting, and dude ranches, and other traditional businesses and recreation, conducive to the western environment.

Recommended Actions or Policies to Help Achieve the Upper Southfork Area's Goals and Objectives for Environment

POLICY #1 USEN:

Coordinate efforts and develop programs to help private landowners and public agencies combat the invasion of noxious weeds including meetings and/or mailing of information.

POLICY #2 USEN:

Encourage preservation of existing habitat.

POLICY #3 USEN:

Encourage grazing of domestic livestock for range health and fire safety.

POLICY #4 USEN:

Limit uses in the Upper Southfork that are detrimental to the public welfare by the emission of unusual and excessive amounts of dust, chemicals, smoke, fumes, odors, gas, noises, or vibrations.

POLICY #5 USEN:

Zone for development compatible with area.

POLICY #6 USEN:

Discourage the development of additional campgrounds.

POLICY #7 USEN:

Don't exclude human activity under the disguise of helping the environment.

POLICY #8 USEN:

No unnecessary roads in forest.

POLICY #9 USEN:

Follow guidelines for multiple use that do not degrade the scenic, aesthetic, agricultural, and recreation values of the Upper Southfork.

POLICY #10 USEN:

Require industries to use appropriate technology for any mining, timbering, or oll drilling activities in order to make these activities unobtrusive and environmentally safe.

POLICIES (cont.)

POLICY #11 USEN.

Encourage biannual meetings with landowners and government agencies to gather local input for game management, grazing policies, and land use policies.

POLICY #12 USEN:

Control noxious weeds through dissemination of information to familiarize and enhance awareness.

POLICY #13 USEN:

Limit logging to selective cuts -- no clear cutting.

POLICY #14 USEN:

No open plt mining.

POLICY #15 USEN:

Fully mitigate the effects of gravel mining.

Provide for the orderly development, use, and conservation of the county's renewable natural resources and for the orderly development of non-renewable natural resources.

Encourage citizen involvement in implementation, enforcement, and changes in the new County Plan.

Encojurage preservation of agricultural lands and open spaces.

The body of customary beliefs, social forms, material traits including the traditions of racial, religious, and social groups, and their morals. knowledge, customs, religions, law. beliefs, superstitions and art.

Custom:

A common tradition or usage so long established.

Discourage:

To seek to check, hinder or deter by disfavor.

Educate:

To make information available.

Encourage:

To stimulate and inspire with action,

courage, spirit, and hope.

Enhance:

To augment or increase.

Holistic:

Emphasizing the organic or functional relationship between

parts and wholes.

Home-Based Business:

A commercial activity which is conducted by a person on the same lot as where the person resides, and which is clearly incidental and secondary to the use of the dwelling for residential purposes and does not involve the alterations of residential facilities which change the residential character of the

property.

Manage:

To control and direct,

To reduc the smallest possible

Minimize:

number of extent.

Monitor:

The periodic observation and orderly collection of data to evaluate the effects of management actions and the effectiveness of actions in meeting objectives.

Multiple Use:

The management of lands and their resources so that they are utilized in the combination that will best meet the present and future needs of the American people: making the most Judicious use of the land for some or all of these resources or related services over areas large enough to provide sufficient latitude for periodic adjustments in use to conform to changing needs and conditions; the use of some land for less than all of the resources: a combination of balanced and diverse resource uses that takes into account the long-term needs of future generations including , but not limited to, recreation, range, timber, minerals, watershed, wildlife and fish, and natural scenic,

scientific and historical values; and harmonious and coordinated management of the various resources, each with each other. without permanent impairment of the productivity of the land and the quality of the environment with consideration being given to the relative values of the resources and not necessarily to the combination

of uses that will give the greatest economic return or the greatest

output per unit.

Preserve:

To keep in tact unless the CPS is amended to permit loss or depletion.

Prevent:

Hinder the progress, appearance, or fulfillment of.

Promote:

To contribute to the growth. enlargement, health or prosperity

Protect:

To shield from encroachment or harm in consideration of other factors or needs that might destroy. injure or have detrimentally effects.

Recognize:

To acknowledge.

Reduce:

To diminish in size, extent, amount

or number.

Reduce:

To decrease.

Require:

To ask or insist.

Restrict:

To limit by number or condition.

Retall/

Commercial:

The sale of goods or services to consumers with the primary aim of
