- Population: Average 175 new residents per year (0.64% per year)

- Kathleen Jachowski asked about ag numbers.
- Kathleen Jachowski addressed local government's role in understanding and literacy (government vs. public) of NEPA. Training is available to understand NEPA.
- Tracy Lafollette asked about farming employment numbers
- Richard Lasko asked about the growth models through 2040. He asked about a metric for remote workers and in-migration. He doesn't bet on 33K thinks it might go higher based on previous rate of growth being higher. Matt can look at factors related to vacancy rates including seasonal homeowners.
- Marion Morrison asked about the impacts to agriculture study will it take into consideration the aesthetic values that come along with the open spaces created by ag properties. Rebekah said they will also be looking at wildlife interactions and value.
- Rebekah Burns talked about student numbers.
- Kathleen Jachowski said the population is Anglo-Saxon and you will see a change in that b/c the in-migration will be different.

- Mike Bromley asked about the trends – are they being compared with local states in the Mountain region. Matt said they had done a study in Montana's Beartooth region and the housing pressures they have experienced. They have information for other nearby areas as well.
