PARK COUNTY, WYOMING 2023 FEE SCHEDULES FOR SERVICES OFFERED BY OFFICES OF ELECTED OFFICIALS AND VARIOUS COUNTY DEPARTMENTS

WHEREAS Park County is a political subdivision of the State of Wyoming and is subject to the provisions of the Wyoming Public Records Act ("Act") W.S. § 16-4-201 et. seq.; and

WHEREAS the County of Park, Wyoming (Park County), is a depository of public records and provides services to make those records available to the public; and

WHEREAS each County elected official and department head is considered a custodian or official custodian of County public records; and

WHEREAS the public records not privileged or confidential by law are open to inspection by any person during regular business hours of Park County in accordance with law and within the parameters of W.S. § 16-4-202; and

WHEREAS the public records of Park County are in various formats including, but not limited to, paper, electronic and other physical forms; and

WHEREAS W.S. § 16-4-202(d) establishes the requirements for the electronic copying or inspection; and

WHEREAS W.S. § 16-4-205 provides for penalties for any person who knowingly or intentionally violates the provisions of the Act;

WHEREAS W.S. § 16-4-204 allows for official custodians to charge reasonable fees for copies, printouts or photographs, as well as services rendered in supervising the copying, printing out or photographing;

WHEREAS certain fees, or allowances to charge reasonable fees, for records, services and/or permits have been set by statute; and

WHEREAS this Resolution replaces and supersedes previously recorded resolutions pertaining to public records fees or fee schedules for services and/or permits established by the following offices or departments of Park County, Wyoming;

WHEREAS the Park County Board of Commissioners held a public meeting on December 20, 2022 to consider a proposed new fee schedule for the services and/or permits provided by each County elected official's office and other departments;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners hereby approve the 2023 Fee Schedules for Services Offered by Offices of Elected Officials and Various County Departments;

BE IT FURTHER RESOLVED by the Board of Commissioners that the following fee schedules are attached and incorporated herein, to become effective as of January 1, 2023:

Applicant is also responsible for all costs associated with new/replacement mailboxes, culverts, signs, fence, and cattleguards associated with private driveways or frontage related to the County road right-of-way. Right-of-way Permit Applications that involve multiple category "Types" will only be charged a fee for the highest "Type". For example, an application for a new driveway access that also requires a culvert, mailbox, and a cattleguard will require only the "Type 4 New Access Fee".
- 2. A <u>new</u> public utility or extension fee is for the first \$1000 feet or less. For longer public utility line(s) or extension(s), the fee shall be the base fee (\$300) plus \$100 for each additional 1000 feet of utility line (calculated proportionally based on the actual lineal footage installed as verified by Park County Public Works Department).
- 3. All listed maps and documents may be downloaded in digital format from the Park County web site at www.parkcounty.us on the Public Works Department page.
- 4. Includes labor and direct benefits.
- 5. Does not include the cost of operator. See labor rates for the cost of operator(s).
- 6. \$150 for the first sign, and \$100 per each additional sign.
